Homework: The homework will be online and due each Friday of non-exam weeks. The online system is WebWork, which is free to students. Your login is your link blue ID in all CAPS (mine would be NADR222), and your initial password is your student number without the leading 9. Calculator: For exams and quizzes, the problems will be designed so as not to require a calculator. Therefore, there will be no calculators allowed for exams and quizzes.

Absences: If you will miss a quiz or exam, you must notify me as soon as possible. You will need to provide appropriate documentation. Senate Rules 5.2.4.2 defines the following as acceptable reasons for excused absences: (a) serious illness, (b) illness or death of family member, (c) University-related trips, (d) major religious holidays, and (e) other circumstances found to fit "reasonable cause for nonattendance" by the professor.

Students anticipating an absence for a major religious holiday are responsible for notifying the instructor in writing of anticipated absences due to their observance of such holidays no later than the last day in the semester to add a class. Two weeks prior to the absence is reasonable, but should not be given any later. Students are expected to withdraw from the class if more than 20% of the classes scheduled for the semester are missed (excused) per University policy.

Per Senate Rule 5.2.4.2, students missing any graded work due to an excused absence are responsible: for informing the Instructor of Record about their excused absence within one week following the period of the excused absence (except where prior notification is required); and for making up the missed work. The professor must give the student an opportunity to make up the work and/or the exams missed due to an excused absence, and shall do so, if feasible, during the semester in which the absence occurred.

Verification of Absences

Students will be asked to verify their absences in order for them to be considered excused. Senate Rule 5.2.4.2 <<u>http://www.uky.edu/Faculty/Senate/files/Excused%20Absences%209-2-09.pdf</u>> states that faculty have the right to request "appropriate verification" when students claim an excused absence because of illness or death in the family.

* A student must notify the Instructor of an absence prior to the absence or within one week after the absence. SR 5.2.4.2.E.

* A student must submit any written documentation supporting an excused absence within one week after the absence, except when the absence is for the observation of a major religious holiday.

* An absence for a major religious holiday or University-related trips requires advanced written notification two weeks before the event.

* In the event of serious illness a University Health Services Tier 2 or Tier 3 excuse is required, or a similar note from a health care provider who will confirm that you are a patient and were seen on the indicated day. Tier 1 excuses will not be accepted.

Dead Week

Classes continue as usual. Homework is due and the typical measures of in-class participation will be present. No papers or exams will be given during dead week.

Academic Integrity

If the words of someone else are used, the student must put quotation marks around the passage in question and add an appropriate indication of its origin. However, nothing in these Rules shall apply to those ideas, which are so generally and freely circulated as to be a part of the public domain.
