

## MA 113/MA 193 : Calculus I

**Overview of Course:** A course in one-variable calculus, including topics from analytic geometry. Derivatives and integrals of elementary functions (including the trigonometric functions) with applications. Lecture, three hours; recitation, two hours per week.

**MA 193:** In addition to the 4 hours of credit for MA 113, the department offers one additional hour of credit as MA 193 on a pass/fail basis. You will pass MA 193 if you have no more than 2 unexcused absences during MA 113 recitations and you pass MA 113. If you fail MA 113 or have 3 or more unexcused absences in recitation, you will fail MA 193.

Your section number for MA 193 must be the same as your section number for MA 113. If you drop or change sections of MA 113, please make sure to also drop or change sections of MA 193. It is your responsibility to do this if you change sections. If you do not change the section of MA 193 you may receive a failing grade for MA 193 because you are not on the proper class roll.

**Attendance Policy:** Attendance is mandatory. You need to be on time and remain until dismissed. Do not leave in the middle of class. Three tardies (or leaving class early) will equal one absence. Students who are not participating in class may be marked absent. If you cannot come to lecture or recitation and would like to request an excused absence, inform the instructor as early as possible and provide documentation.

**E-mail Policy:** I will try to answer any emails within 24 hours. However, any email sent after 6 p.m. may not be answered until the following day. So, please email me as soon as possible.

**Excused absences:** Students need to notify the instructor of absences prior to class when possible. Senate Rules 5.2.4.2 defines the following as acceptable reasons for excused absences: (a) serious illness, (b) illness or death of family member, (c) University-related trips, (d) major religious holidays, and (e) other circumstances found to fit "reasonable cause for nonattendance" by

the professor. Students anticipating an absence for a major religious holiday are responsible for notifying the instructor in writing of anticipated absences due to their observance of such holidays no later than the last day in the semester to add a class. Two weeks prior to the absence is reasonable, but should not be given any later. **Materials:** You are expected to have everything you need in order to complete your recitation worksheets, including lecture notes. You also expected to print out your own recitation worksheets. You are also encouraged to work on your homework prior to class.

**Electronic devices Policy:** Electronic devices such as mobile phones, laptops and tablets should be put away.

**Quizzes:** Quizzes will be given on most Thursdays during recitations at the end of class. Calculators will not be allowed for quizzes. The quiz grades contribute to your overall course grade.

**Academic Integrity:** Students are expected to abide by University policy in regards to academic integrity. You should feel free to study with friends and classmates, but any work you submit for a grade should be your own work. This applies to all exams, quizzes, and writing assignments. Academic dishonesty, in any form, will not be tolerated. No materials should be visible during exams. Any kind of communication with other students during an exam will be considered cheating and will be dealt with according to university regulations.

**Disability Accommodations:** If you have a documented disability that requires academic accommodations, please see me as soon as possible during office hours. In order to receive accommodations in this course, you must provide me with a Letter of Accommodation from the Disability Resource Center for coordination of campus disability services available to students with disabilities.

**Personal Conduct** While class is relatively informal, I ask that you exhibit common courtesy toward me and your fellow students and that you refrain from disruptive behavior. The university, college, and department has a commitment to respect the dignity of all and to value differences among members of our academic community. Students who are disrespectful, not civil, or disruptive in any way may be asked to leave the class.

**Student Conduct in the Classroom:** Code of Student Conduct (AR 4.10), Section V, Letter J, Instructional Setting Behavior: "Students who engage in conduct that results in disruption of an instructional setting may be directed by the instructor to leave the class for the remainder of the instructional setting period." Students who violate classroom behavior standards during the lecture or recitation will be marked as an unexcused absence from that day's attendance. Depending upon the severity of the disruption, the student will be asked to leave.
